This circular has not been reviewed by the Central Bank of Ireland (the "Central Bank") and it is possible that changes thereto may be necessary to meet the Central Bank's requirements. The Company's Directors are of the opinion that there is nothing contained in this circular or in the proposals detailed herein that conflicts with the regulations of, the Central Bank or with best industry practice. The Directors accept responsibility for the information contained in this circular.

All capitalised terms used in this circular and not defined herein shall have the meanings ascribed to them in the Company's current prospectus dated 30 June 2023 and the supplements for the Funds (together, the "Prospectus").

Aegon Global Short Dated Climate Transition Fund Aegon Global Short Dated High Yield Climate Transition Fund (each a Fund, together the "Funds")

We are writing to you in your capacity as a Shareholder in the Fund(s) to inform you that we intend to make the below update to the Funds.

Climate Transition Categories

As part of the climate related transition analysis carried out by the Investment Manager on issuers in respect of the Funds, the Investment Manager assigns issuers a climate transition category and looks to limit exposure to issuers categorised as 3- "Transitioning", 4- "Unprepared", or 5- "Laggard" to enable a consistent and measurable downward trend away from investment in such issuers over time, as follows (in each case as a percentage of Net Asset Value):

Climate Transition Category	Current	End 2024	End 2029	End 2034	End 2039
Leader	No maximum limit			100%	
Prepared	No maximum limit			100%	
Transitioning	< 80%	< 60%	< 40%	< 20%	0%
Unprepared	< 40%	< 30%	< 20%	< 10%	0%
Laggard	< 10%	< 5%	0%	0%	0%

It is intended to update the supplements for each Fund (the "**Supplements**") to allow for any unused percentage in a climate transition category to be aggregated to a higher category. For example, under the 'Current' column, if only 5% of the Fund's portfolio is held in "Laggard", up to 45% may be held in "Unprepared". This is to ensure that the downward trend away from investment in the lower categories can continue on a faster trajectory where possible.

This change will become effective on or about 14 June 2024 or on such other date the changes to the Supplements are noted by the Central Bank (the "Effective Date").

You do not need to take any action as a result of this notification, although we recommend that you read it carefully. The proposal does not result in any change to the risk profile of the Fund nor any realignment of the portfolio.
