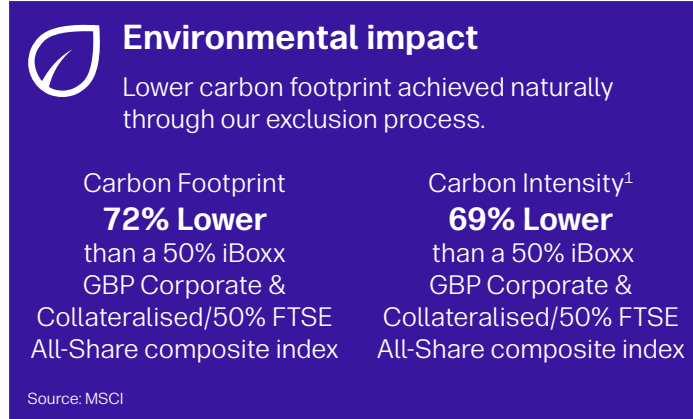
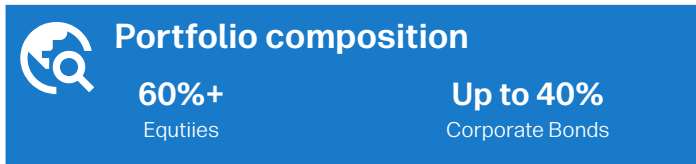

The Fund uses an ethical screen to limit or avoid investments in companies involved in activities that may be considered as having an adverse effect on society or the environment and are generally considered unethical. ## Active ownership and engagement

Aegon Asset Management UK plc is the Authorised Corporate Director of this Fund.

Being an active owner is at the core of our Responsible Investment approach. We believe promoting good ESG practices within our fund holdings is essential for safeguarding the long-term interests of investors and society. Our active ownership approach focuses on enhancing long-term value through direct company dialogues, proxy voting and ESG risk management. Engagement progress is tracked through four key milestones
