Aegon Asset Management Europe ICAV (the "ICAV") - Share Class Closures

I am writing to inform you that the Board of Directors have taken the decision to close a number of share classes within the ICAV fund range below (the "Share Class"). These closures, which are listed below, will take effect from 21st February 2024.

Why have we decided to close some of our share classes?

We constantly review our fund range to ensure the products and share classes we offer reflect the needs of our clients. Given the limited demand for the attached list of fund share classes, they are no longer of sufficient scale to meet their stated objective, and we have therefore decided to close them. More popular share classes for the same funds remain.

The last Dealing Day for the Share Class will be 21 February 2024. Please read this letter carefully as you may wish to act now to avoid your investment in the Share Class being automatically redeemed and the proceeds paid back to you.

What are your options?

There are a number of options available to you, which are outline below:

- 1. You can redeem your investment until **13:00 hours (Irish time) on 21 February 2024** by faxing your instruction to the Administrator at 00 353 1 622 4604 or through your usual dealing method.
- 2. You can switch your investment into another share class of the same currency, within the Fund or other fund(s) within the ICAV. Full details of all available share classes within the Fund (and other funds) are available at www.aegonam.com.

Please note that there is more than one share class closing at this time (as set out in Appendix I). If you select to switch into one of the impacted share classes your investment will subsequently be automatically redeemed on 21 February 2024.

Both of these options are free of charge. If you choose either of these options, please let us know before 13:00 hours (Irish time) on 21 February 2024 by faxing your instruction to the Administrator at 00 353 1 622 4604 or through your usual dealing method. It is important that you read this information fully before making any investment decisions, taking independent advice, including tax advice, where appropriate.



Take no action

If you take no action by **13:00 hours (Irish time) on 21 February 2024**, (or switch into a share class in the process of closing) we will redeem your investment with effect from 23:00 hours on the same day. Settlement proceeds will be sent within three working days to your bank account if we hold verified details.

Are there costs associated with the closure of the share class?

All costs directly associated with the share class closure (other than any transaction costs) will be met by the Investment Manager, Aegon Investment Management B.V.

I would like to take this opportunity to thank you for investing with the ICAV and hope you will consider transferring your investment to one or more of our other share classes or funds.
